SUB: The mechanism for submitting wishing to transport goods by transit method

The Embassy of the Republic of Iraq, Commercial Attaché would like to present its compliment to your esteemed Organization, and for enhancing the commercial & economic relations between our two countries.

First: Companies wishing to transport goods in transit through Iraqi territory shall submit the application at the headquarters of the General Company for Land Transport after completing the following conditions and instructions:

1- Submitting an application by (the owner of the goods or the carrier company) to the concerned in the General Company for Land Transport for the purpose of obtaining approvals for the transportations its goods through Iraqi territory.

2- Providing the General Company for Land Transport with identification papers and documents that support the transportation of goods by transit system through Iraq (transfer or agency contract (goods) it contains the details of the transported goods (quantity and type).

3- Submit a list that includes (the name of the triple driver-the number of the truck and its destination- its registration - the chassis number - the type and weight of the loaded goods exit port) for the purpose of determining the path of roads through - the entry port - the Iraqi territory that the trucks take to the exit port and in coordination with the operations room represented by the security authorities and departments concerned with the subject.

4- The submitted companies wishing to transport goods according to the transit system must be an Iraqi company registered with the registrar of companies or foreign company for it agent inside Iraq.

5- Submitting a written pledge through a notary by the requesting party, pledging to bear full responsibility in the event of a violation of the information provided.

Second: The General Company for Land Transport after submitting the application. 1-Studying and matching the submitted application with the controls established by the higher

Committee for transit.

2- Verify the issuance of the information of the company concerned with the registrar of companies in the Ministry of Trading.

- 3- After the submitted company fulfills all the conditions, the General Company for Land Transport informs the members of the departments (ports Authority- Customs-Department of Residence Insurance) who are in the operations room and Passport- Joint Operations HEALTH. The joint company requested the carrier to approach their competent departments to expedite the procedures.
- 4- Provide the carrier with a schedule of transit fees and the controls and measures taken and Approved by the High Transit Committee.
- 5- The General Company for Land Transport, in coordination with the joint Operations Room, determines the route from the entry port to the exit port, and this is fixed on the Truck.
- 6- The GPS tracking device is attached to the cargo at the port of entry and followed.
